Shown below is a philatelic overview of the perfin/precancel/prepper history of St. Louis, MO, our Convention's host city. A listing of perfin users whose primary user location is listed as St. Louis is far more robust than that for North Charleston, SC, location of last year's Convention (121 patterns vs. 3). Surprisingly, only 12 of the perfins listed for St. Louis lack an identification for the primary user; all others have their primary user identified in the most recent *Catalog*.

The patterns (*reproduced at 90% of actual size*) and their catalog numbers, plus identifications reported for the primary user are shown below.. *Note that an "\$" following the catalog number indicates the use of the pattern by both a primary and a supplemental user in St. Louis; an "*" indicates that the pattern is known in precanceled stamps.*

Perfin patterns A075 and S284 are reported to exist as prepers but are not listed in Smith's catalog.

In summary, of the 121 perfins with primary user in St. Louis, 5 are A rated, 5 are B+ rated, 15 are B rated, 16 are C+ rated and the remaining 80 are rated C or lower, and thus, most should be available for a reasonable investment of your stamp budget. The cost of confirming covers for the 56 supplemental users reported, would present a slightly different picture of availability. Most of these are in collections, and are simply not generally available. And, finally, for those collecting prepers, V raters (scarcity comparable to A rated perfins) account for a total of 26 of the 62 types; W rated (~B rated) another 12; X rated (C rated) 12 more; with the remaining 12 being common.

A representative collection of Saint Louis perfins seems possible for even the collector of average means. A representative collection of prepers is also possible, though somewhat more pricey. However, the collector of supplemental users of St. Louis perfins will probably have trouble even locating, much less procuring, them.

Price and availability aside, the fun is in the hunt, so, above all, have fun hunting both the common and the elusive!

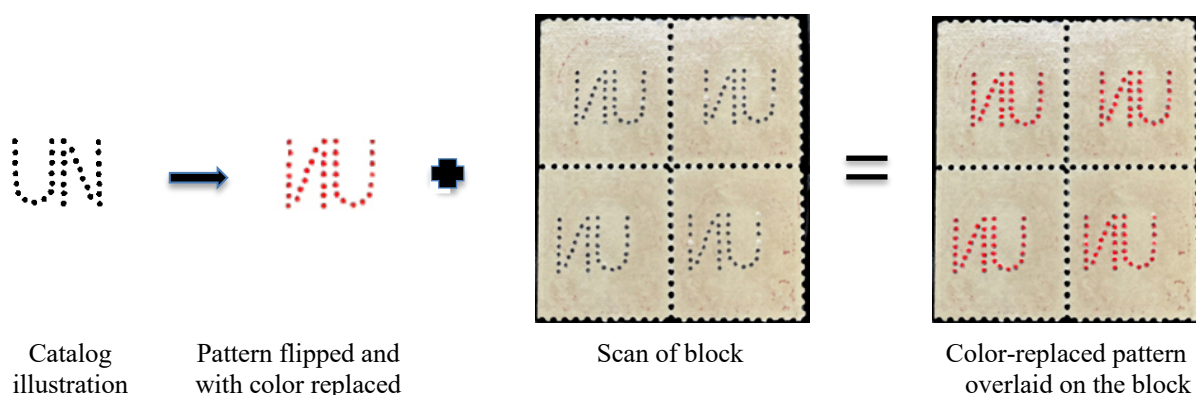
Canal Zone UN Perfin Revisited

In the last issue of the *Bulletin* [*The Perfins Bulletin* 78(3):52] I presented a question related to the genuineness of a block of four 2¢ red Washingtons with “Canal Zone” overprint and the perfin “UN” of University of Nebraska in all four stamps. While the note was accurate as far as it went, however I completely forgot that Robert Littrell has recently replaced Schwerdt’s 1992 *The World Perfins Catalog: Americas* with a significantly updated *The World Perfins Catalog: American Section* (3rd ed., 1st revis.). Apologies to Robert, senior moments are a pain.

Below are presented four responses to that article which add significantly to the knowledge of these questioned items. As yet there is no closure to the question. Hopefully, expertization of the block will answer definitively whether the stamp with overprint and perfin are genuine. Sadly, confirmation of the genuineness (or not) will not answer the underlying question of *why* these perfins exist at all.

Since the article was written, I have Photoshop-extracted the perfin pattern from Endicott’s *Catalog of United States Perfins* (2021) and overlaid it on each of the four patterns in the block. The result, shown below (reduced in size) indicates that the perfin is indeed pattern U043 used by the University.



U.S. Commercial Perfins on Canal Zone Stamps

Gary B. Weiss (#LM15) and Bob Szymanski (#LM145)

The most recent issue of *The Perfins Bulletin* (volume 78 (3) May/June 2024 page 52) includes a brief note about a University of Nebraska perfin in Canal Zone Scott No. 74. It questions whether it is genuine and also questions its value. The questions raised about this perfin could be asked about any perfin. Whether a mint perfin is "genuine" may always be questioned. For example, the stamp could have received the perfin as a philatelic favor, the use of the perforator could have been unauthorized or done long after the perforator had been retired, or it could be a total fabrication. One of us (GBW) has several examples in his collection including a single of the UN perfin in CZ Scott No. 74. We are sure that all of the Canal Zone stamps are genuine. The perfins are also excellent matches to US perfins and we consider it unlikely that the perfins are fake. This and other contrived perfins known in Canal Zone stamps are the subject of this article.

The Johnson Smith Company (JSC, U.S. Perfin Catalog No. J144) sold novelties from a catalog worldwide. Their 1939 catalog stated, "We will accept good, clean, unused U.S. Postage Stamps of any denomination in payment of orders". It also notes, "Send 3¢ for our 576-page novelty catalog." Their perfins are known in several mint values of the 1939 Canal Zone 25th anniversary series, Scott Nos. 120-135. So far, only the 3¢, 5¢, 10¢ and 50¢ are documented. All are very scarce. Putting these two observations together, it is likely that some Canal Zone customers paid for their orders with Canal Zone stamps rather than U.S. stamps. We suspect that some or all were accepted. These stamps would then have had the security perfin added and were finally placed in stock for use in mailings. They may have been detected before being used for mailing and not used. At some time, these unused stamps may have been sold or given to collectors. We believe that these stamps and their perfins are genuine, but they were never used in the Zone by the Johnson Smith Company.

The University of Nebraska (UN, U043) and other universities frequently mailed applications and catalogs to prospective candidates; most now have their material available on their web site. We remember including a SASE when applying to colleges. We are aware of 2 blocks of 4, one pair and six mint singles of CZ Scott No. 73. Some examples of CZ overprinted US stamps without perfins are known used in the US. It is possible that these stamps were sent to the university for applications or catalogs. If

so, they could have been handled similarly to the handling by Johnson Smith Company. Again, we believe these are contrived (genuine, but never used in the Zone).

The rest of the examples discussed are all "one of a kind". The first is on a cover front and is discussed first (Figure 1). The damaged special delivery stamp is probably US Scott E11 (watermark not checked) and it has a CNB perfin (US Perfin Catalog No. C212) which is from either Chase National Bank or Commercial National Bank. US special delivery stamps were sold at CZ post offices, used from the Canal Zone, generally cancelled in the US, but frequently not cancelled. The cover appears typical of CZ special delivery mail of the period. As this stamp is not tied to the cover, it cannot be proven that it originated on this cover (but the cover did contain a special delivery stamp when mailed).

The next two stamps are used examples of Canal Zone Scott No. 115. The first has RI perfin (R75.5) from the Rock Island and Pacific Railway Company based in Chicago (Figure 2). The second has BFCo perfin (B112) of the Buffalo Forge Company (Figure 3). The cancel may be from Buffalo. It is difficult to explain why these perfins should exist in a Canal Zone stamp. The most favorable explanation would be that these were contrived, possibly done created using used stamps.

Finally, Wes Dunaway published an article on Canal Zone perfins in the *American Philatelist* (80:931-934, 1967). He illustrated additional perfins, C in circle, US Perfin Catalog No. C005.5, (ex-Tatelman, only reverse shown; a possible second example in CZ 114 appeared in a 2009 auction described as "C with rays" and sale price of \$160); FLP (F153, Famous Players Lasky, a movie film production company) in Canal Zone #79 (ex-Salz); G in crown (G14, Gruen Watch Company) in CZ #93; and PPI/EC, the perfin of the Panama Pacific International Exposition (design shown, but the stamp was not identified or illustrated).

Dunaway suggests that these were not punched in the Canal Zone and might have been punched accidentally. He also notes that large mail order companies often sent parcels in bulk by boat to the Zone. The parcels, pre-franked with CZ stamps, were turned over to the CZ postal service for delivery. This explanation might apply to any higher denomination stamps.

Concerning value, collectors of Canal Zone stamps approach and value perfins very differently than general perfin collectors. The general collector wants one example of each pattern; multiples are not very important, and covers are of interest primarily to identify the user. In contrast, the country collector wants examples of each stamp design for each perfin, may collect varieties such as perfin orientation, and pay premiums for multiples and covers. Recent auctions have sold rare perfins on cover for over \$1000 and rare single perfins for close to that price. The value of these undocumented stamps is hard to determine. The items from my collection were all obtained as parts of large lots; the price I paid for each stamp in such a large lot is arbitrary. These stamps were not the reason I made the purchase and the value I assigned to these was minimal. The only recent auction realization I can find is the block of four of the UN perfin in CZ #73 in the Bates auction (\$250 + 20% + tax = \$300). Examples of JSC and UN perfins on eBay were listed at \$200-300 per stamp but I am unaware of any actual transactions. If several Canal Zone collectors want these in

their collections, high prices may be warranted. If they are not needed (for completion) of a CZ collection, they would have only minimal value. Additional examples, especially on cover, should be reported to the Editor.

Another Approach to Resolving this Conundrum

I shared a scan of your Perfin Bulletin article in a Facebook group (eBay Or Hipstamp fraudulent U.S. stamps) which is something of a “watchdog” group for scammers on the internet. Perhaps some of those users may have some insight on the curious block of Canal Zone perfins. I also found what appears to be the web site of the sellers “KurtS”, and that is: <https://ksphilatelics.com/>. On the site, the seller purports to specialize in Canal one and US Possessions. The APS website lists ksphilatelics as a Member-Dealer.

Based on all this, it would seem the seller is “on the up-and-up”, so perhaps if the item is not genuine, it is an item acquired from someone less conscientious. It has been my observation over the past few years that overprints have been a ripe area for counterfeiters and one US-collecting colleague has observed that nearly all Kansas-Nebraska overprints on the market now are likely faked. It seems perfectly reasonable to me that KS Philatelics should provide a high-resolution scan of the item, even for a nominal fee. In fact, it is my opinion that, based on the apparent rarity of the item, there is reasonable basis to presume it may be fraudulent and so it’s authenticity should be verified by the seller within the APS code of ethics. Item 7 of that code reads “I agree not knowingly to sell, trade, produce, or advertise repaired, altered, or otherwise modified philatelic items unless that condition is clearly stated. I further agree not to sell, produce, or advertise counterfeit material in any form, in violation of any law.”

I did spend a little time educating myself on Canal Zone stamps out of sheer, philatelic curiosity and did find this rather interesting publication, indicating that there many thousands of this overprint (<https://www.canalzonestudygroup.com/Docs/Dade-Schay.pdf>). Raises the question of whether a sheet mistakenly ended up in Nebraska and was perfinned.

Finally, this block does not seem to be the only such example of the UN Perfin in this stamp. [Ed. note: see paragraph 4 in previous note for more on additional copies.] These examples appear to have a higher quality scan of the overprinted, perfinned stamp. But I do find it curious that all seven examples, blocks, pairs, and singles are being offered by the same seller (buystamps) and all examples are unused. That seller also purports to be an APS Member-Dealer, so they too should have these items verified.

I think you’ve asked a good question about these examples and that the philatelic and perfin communities would be well-served to establish whether the provenance of these items establishes that they are genuine or are altered by fake perfins or added overprints.

Response to Perry and Further Comments

Stephen Tauber (#2949)

Response: My interest in this item is peripheral since it does not fall into my specific collecting interests. (Among perfins I collect only officially prepared patterns.) I notified Paul because the item seemed bogus.

Having all of the examples come from the same dealer may be no more complicated than that they come from the same collection which he bought. As you point out, as an APS dealer he should closely investigate an item as improbable as this.

Further comments from a separate email: Upon close examination of the images of the 7 UN pattern perfins, to my eye there appears to be at least a trace of black on at least one of the edges of one of the holes. If this were verified as correct by examining the stamps themselves, then that would be definitive demonstration that the overprints are fake. Additionally, most of the overprints strike me as being a bit fuzzier than those which I have seen on Canal Zone stamps.

Since the offeror presents himself as an APS member dealer, it should be no problem to have him make that determination. If there is no trace of such black, and the overprints themselves pass muster, then it seems reasonable to submit one for expertization — perhaps such a sheet did indeed wander to Nebraska.

Comments from the Editor of the Updated *Americas Section of the World Perfin Catalog*

Robert Littrell (#3992)

No question that the stamp is genuine, the overprint is genuine, the perfin is that of the University of Nebraska. The only question is why is it in the stamp? How did it get there?

Assuming no cover appears, one can only speculate, but it is worth noting that there were five Canal Zone perfins that I deleted from the revised edition for the same reason: no covers and suspicious perfin origin. Why would the Gruen Watch Company of Cincinnati, OH or any of the other companies have a punch in a CZ stamp? No CZ postmarks appear on any of these stamps according to Schwerdt (see 1st ed. of the *Catalog*).

The common denominator in the six instances (including the UN stamps) is the Canal Zone. Why would such a proliferation of questionable perfin stamps be limited to the CZ (which happen to be highly collectable)? Bob Szymanski calls them “philatelic follies”. Extraneous items happen from time to time, but I have yet to see it happen to this extent in any other small country that I have dealt with. Did someone with an interest in the CZ, or an interest in making money, collect discarded perforation machines? With instances of sales in excess of \$250, it could be profitable, especially if they limited their production numbers!

End Note from the Editor – Where We Stand

Thanks to all for the above input.

The comment by Gary Weiss regarding the value of Canal Zone materials mirrors his note in *Bulletin* from 2019 (73(5):84-85). Clearly nothing has changed in the market for Canal Zone perfins; CZ perfins demand higher prices than perfins from most countries. It is hard for me to rationalize \$200 per copy of the “UN” perfin, a perfin for which a B+ rating with a price tag of around \$50 would apply in U.S. stamps. Fascination with multiples which are not to be further broken and a limited supply might boost the (U.S.) pattern equivalent to a rating of A which still would not command \$200+ a copy.

Of all of the discussion above, the most revealing information in support of genuineness are the two explanations which hadn’t occurred to me when writing the note for the last issue. Two possible scenarios occur based on these two items.

1. The proposition that payment could be made for items in postage stamps is one possible easy explanation if followed. a sheet of these stamps could have been accidentally perfined by an inattentive mailroom clerk. which were subsequently perforated only to be discovered and removed from the supply of available postage, or deliberately perfined by a nefarious one. These perfined stamps could easily have then been trashed to a collector’s accumulation, in mint form.
2. As an alternative, if the company received these stamps to pay postage in the Canal Zone after bulk mail ship transport there, it would again be possible that a sheet of these stamps was perfined (accidentally or deliberately) by the US company shipping to the CZ. This explanation suffers greatly from the almost complete lack of covers or cancelled CZ stamps for any of the six companies for which US company perfins exist in CZ stamps.

Either of these scenarios is possible, but it is hard to believe that the University of Nebraska accepted postage for some product (?publications). We probably will never have that piece of the puzzle.

The opinions expressed seem to favor, but do not actually go so far as to confirm, the genuineness of both the overprinting and the perfin pattern. The slight variations between catalog and perfin seen in the graphic above are not of particular note. Pattern U043 is listed as having been produced by a 5-die perforator, so the exact match is speculated to be one of the three dies not seen in the block. The match is 99% correct is adequate to state that the actual UN perforator was used.

The use of a 5-die head raises another issue. Were the sheets being perforated folded in half (forming a 5 x 10 stamp double thickness “sheet” before being fed through the perforator? And if it (or they) were folded, do mirror image blocks of the one offered for sale exist? And, further, do tête-bêche pairs or blocks exist from the enter columns (cols. 5 & 6)?

In the final analysis, however, it would be nice to have the block offered for sale, or another of them, expertized.

Bulk Perfins – Still Cheap?

I read Charlie Adrion's article entitled, "\$1.25/1000 – How Time Have Changed" and the editorial response by Paul Mistretta with interest. It got me to thinking about the value of a dollar in 1960 vs. today, and if there were comparisons to lots I see today. Let's examine two auctions, the first being the Perfins Club Auction where it is routine for me to advertise Lots of 500 perfins with a reserve price of \$15. The second auction being the Great Britain Perfin Society's, where the last 4 auctions have been selling large lots of Queen Elizabeth II decimal perfins. Let's do a bit of analysis, shall we?

The ad on the postcard from Dave Stump in 1960 (shown in Charlie's article) advertised 1000 perfins for \$1.25. So exactly how much is a 1960's dollar worth today. Any currency calculator will quickly tell you that the 1960 dollar is worth \$10.59 today. Still, a good deal at 1.06¢ per perfin in today's currency value. Now let's do a bit of conversion. Lots 137-146, despite there being 4 different bidders, sold for the minimum, \$15 each. That is only 3¢ per perfin even though the same caveat stated by Dave Stump holds; if you have over 2,000 perfins, these lots are not for you. So, cheap perfins in the US Perfins Club's reviewed lots are about 3 times as much now, as they were in 1960.

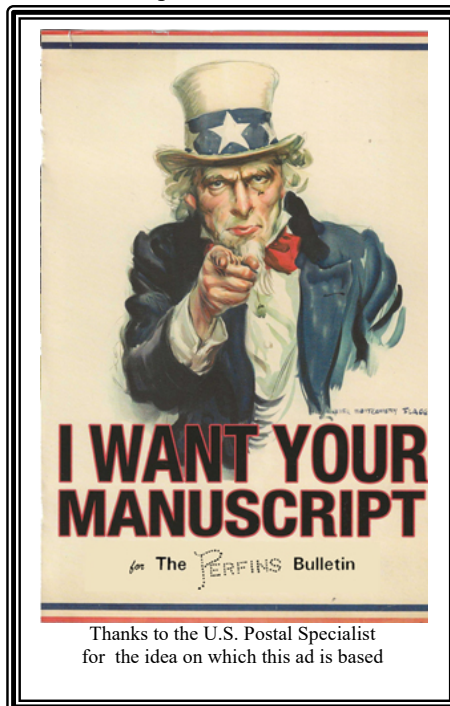
Moving on to the last 4 Perfin Society auctions. Auction 133 closed 15SEP23; 134 closed 10NOV23; 135 closed 15MAR24 and finally 136 closed 4MAY24.

Bulk Rate Perfin cost – cont. from p.79

In auction 133, there was a bulk lot of 50,000 Machin perfins with a starting price of £100. That lot realized £675.10 or 1.35p per perfin. Today's exchange rate is \$1 = 78p making the cost per perfin 1.73¢ Not much more than the 1960's price of 1.06¢ per perfin. In auction 134, there was a lot of 10,000 perfins. It sold for £175.90 or 1.759p per perfin equivalent to 2.55¢ per perfin. Still reasonable. Along comes auction 135 with another lot of 10,000 perfins which sold for £55.10. Now we have a bargain. Each perfin was .551p each equivalent to 0.706¢per perfin – less than the 1960's price. In auction 136, another lot of 10,000 perfins sold for £100.10 or 1.001p per perfin. Another bargain, equivalent to 1.283¢ per perfin, just barely above the 1960's price.

In conclusion, bulk perfins are almost as cheap today as they were 64 years ago. This follows that old investment axiom that it takes money to make money: rare items continue to climb in value, cheap stuff remains cheap. From a collector point of view, I want even the cheap stuff as I am not an investor, I am a collector, and I can have as much fun with cheap perfins as I can with the more expensive ones.
